My Options Activities

A number of issues were discussed in relation to the Targeted activities provided by My Options (Sports & leisure, Arts & Crafts, club 17):

- Recruitment issues affect what we're able to offer and how much. We are constantly recruiting for staff and if you can help with this, please let us know!
- There are more bookings than we have capacity for Sports & Leisure, so we offer sessions to everyone who books on so no-one misses out. This may be offered as every other Saturday until we have more staff on board.
- We would like to confirm that Sports & Leisure do have 1:1 and 2:1 slots, so that children with more complex needs can attend.
- We have heard the ask for Sports & Leisure to be for longer than 2 hours and we will continue to work on how we could do this, capacity allowing.
- We note that Club 17 does not cater for children with personal care and toileting needs which means these children are not able to attend by themselves.
- We think we can develop the Arts & Crafts offer, and will look at some alternative options to bring to our next meeting.

Preparation for Adulthood

A previous Preparation for Adulthood conference was really positive and you'd like to see another one of these – we will certainly see if we can do that.

A Preparation for Adulthood programme for people aged 18+ is being developed. There is future potential for this to be offered to younger people.

During this time, Childrens Services will embed the Preparation for Adulthood approach within our procedures so that we better support young people into adulthood.

Future potential housing options for when young people become adults are being considered from age 14 so that housing providers can be advised.

'We're Coming to See You' document idea

We talked through how we can better support children and young people to prepare for social care visits and discussions, by providing prior information in accessible formats so that young people can think about their needs and options. This is a really good idea that we wish to develop with you.

Current Market Issues

- Acorn Way remains closed while Care Tech (the provider) recruits locally. If you know anyone who would be interested in this very rewarding role, please get in touch!
- There is encouraging interest in Short Breaks foster carers and anticipate some offers over the coming weeks. Again, if you know anyone interested in this get in touch.
- We have been in contact with a couple of new Care and Support providers that wish to offer a service in Telford. We will update you once we have them signed up to our frameworks and available to you.
- We're exploring options for use of a local cabin for use by families and for respite
- We will improve our direct payment and PA recruitment support to families. We may need to check out our approach with you, hold a workshop, look at new and creative ways of recruiting PA's and link to Local Authority PA marketing campaigns.
