## Ofsted and Care Quality Commission evaluation of LA SEND inspections.

Ofsted and the Care Quality Commission (CQC) are conducting a joint evaluation of the arrangements to inspect local area SEND provision and we would like to thank you for agreeing to contribute to this important work.

We are conducting research to evaluate our own inspection policy and practice. We want to make sure that the methods of inspection are as valid and reliable as they can be.
